LABORATORY EQUIPMENT

PART 1 GENERAL

1.01 SECTION INCLUDES

- A. Lab Equipment:
 - 1. Fume Hoods
 - 2. Ice Maker
 - 3. Lab Glassware Washers
 - 4. Acid Storage Cabinet
 - 5. Flammable Storage Cabinet
 - 6. Goggle Cabinet

1.02 QUALITY ASSURANCE

- A. All equipment shall be UL rated. Provide each type of equipment from a single manufacturer, and to the extent possible, provide all equipment by a single manufacturer.

PART 2 PRODUCTS

2.01 MATERIALS

- A. Fume Hoods
 - 1. Labconco (or equivalent) pass through, with Air, Gas, Hot and Cold water and built in cup sink.
 - 2. Pre-wired and plumbed for gas, hot/cold water, compressed air, electrical outlets and vapor sealed light fixture and switch.
 - 3. Back-flow prevention device shall be installed on the outside of the cabinet.
 - 4. Base cabinet must have ADA forward approach on classroom side.
 - 5. All power outlets and switches shall be located on the exterior face of the hood (not internal).
 - 6. Internal hood lights shall be fitted with vapor seal lenses.
 - 7. Minimum velocity – 100 fpm, maximum velocity - 120 fpm
 - 8. Locate 10 feet from building air intake or building openings.
 - 9. Vertical sash design.
- B. Ice Maker
- C. Lab Glassware Washers
- D. Acid Storage Cabinets:
 - 1. 15 gallon minimum acid cabinet.
 - 2. All steel construction with integral reservoir base.
 - a) Chemical resistant, baked-on enamel coating
 - b) Interior polypropylene lining
 - 3. Locking doors
 - 4. Chemical spill reservoir
 - 5. Acid resistant shelving
 - 6. Self-closing doors
 - 7. OSHA and NFPA-30 approved

8. Separate poly cube to be provided for nitric acid storage.
- E. Flammable Storage Cabinets:
1. 43" x 18" x 44"
 2. 30 gallon minimum size flammable cabinet.
 3. 4-gallon flammable cabinet to be provided where ammonia nitrate is used (typically high schools)
 4. All steel construction with intergral reservoir base.
 5. Self-Closing locking doors.
 6. Spill reservoir.
 7. OSHA and NFPA-30 Approved.
- F. Goggle Cabinets:
1. 28½" H × 26¼" W × 10¼" D
 2. Store minimum of 36 pairs of goggles.
 3. Wall mounted.
 4. 15 minute timer.
 5. OSHA and NFPA-30 Approved.

PART 3 EXECUTION

3.01 INSTALLATION

- A. Laboratory equipment shall be installed in accordance with manufacturer's instructions.
